Telling Friends and Family

hile you are considering each of your options, we encourage you to seek support from any and all outlets you can, whether it is from loved ones or professionals. If you are comfortable sharing your situation, confide in a trusted friend or family member. Think of who is going to be there for you emotionally, physically and even financially in all aspects of this decision. More significantly, consider who will respect you and the decision you make.

You should also decide the right time to tell others of your situation. Only you will know when the time is right. Many women choose to share before they make a decision and some choose to make their decision independently and later tell family and friends. Many choose to keep it private and that is also okay. You can always come to us. If and when you consider adoption, know that agencies such as **Adoptions With Love** offer counseling through the entirety of your pregnancy. We are also obliged to keep all cases confidential.

If you decide to open up about your pregnancy, keep in mind that everyone you tell may have a different reaction. You cannot necessarily know what reaction it will be—love, support, disappointment, persuasion to change your mind—just know that you will get one.

This is still your decision. Only you know what is right for you and your child. Your family and friends may not understand, but an agency or counselor can be used for support. The Role of the Expectant Father

Informing the expectant father of your pregnancy can be one of the most intimidating parts of your journey. You may or may not have a relationship with him, or even know of his whereabouts. If you are in a situation where it is possible and safe to engage him in your decision, consider being open with the father. He can be a huge part of this process, and he may want to walk this journey beside you.

As an expectant parent, a father maintains certain rights to his child. As a result, some states require that the father be aware of these parental rights and responsibilities. If the father agrees that adoption is the right next step, he is entitled to the same support and counseling as the expectant mother. This decision may be trying and emotional for him as well. Making this choice together will give you each the benefit of supporting one another through the decision-making process. You both can rest assured knowing that you chose the best possible life for your baby together as a team.

If this does not describe your situation, do not worry. There are many instances in which expectant mothers lack any sort of relationship with the father of their child. If this is your case, a licensed adoption agency can contact him through an attorney and present him with his legal

rights as a father. You do not have to contact him directly. If the father is unknown, that is okay, too. The laws pertaining to the birth father's parental rights are different from state to state. Adoptions With Love has the appropriate legal counsel to complete the termination of parental rights.

The laws pertaining to the birth father's parental rights vary by state, so it is important you consult with experts in local adoption laws.



How to Tell the Expectant Father

egardless of your situation and your relationship, it is always best that you tell the truth to the father and about the father. If you decide to parent or place, your child may want to know about him in the future.

If you are considering adoption, but are not sure how to tell the expectant father, think of it as an educational process. You will need to help him understand the advantages of adoption, and explain to him how you arrived at your decision.


Remind him that there are always options. In choosing adoption, he, as an expectant father, can serve a different role than you, as an expectant mother. He may choose to maintain a semi-open relationship, while you may want a fully open adoption. You each get to define your own relationships, with your child and with the adoptive family.

At **Adoptions With Love**, 80 percent of birth fathers are involved to some degree in making an adoption plan. They have supported this positive choice and signed the legal documents allowing the adoption. If a father does not agree with the adoption plan he must be fully prepared to take care of you and the baby in all aspects, emotionally

and financially. If he is ready commit to a child, he must also be willing to commit

to child support.

Financial Consideration and Planning

hen facing an unplanned pregnancy, one of the most important questions to ask yourself is whether or not you can financially provide for your child. If you are considering parenting, having a baby is not solely a moment in time. It requires at least 18 years of steady support, and a lifelong commitment. Think of your future. Are you financially stable enough to accomplish your own goals, while still providing for a child? Will you have time to balance both a career and a baby? Consider these statistics:

According to a recent USDA report, a middle-income family with a baby born in 2013 can expect to spend about \$245,340 on that child up until the age of 18. While this number includes most child-rearing expenses, it still does not involve any costs associated with your pregnancy or any expenses that occur after your child turns 18, such as a college education.

- 30 percent of this figure accounts for housing, and all costs associated with putting a roof over your child's head for the first 18 years.
- 18 percent of child-rearing expenses are the high cost of childcare and primary education. Daycare costs an average of about \$11,666 annually. Based on a regular workweek, this equates to almost \$6 an hour, 40 hours a week.
- 16 percent of your total child-rearing expenses are comprised of the amount spent on food, formula, and diapers, to name a few. It is so important to prepare yourself, as the first years are often some of the most expensive. An average infant will use about 100 diapers a week which can cost between \$600 \$1,000 per year. While food can sometimes be compensated with government assistance, diapers remain an out of pocket expense.
- Even the little things do not seem so little when you begin your parenting journey. 14 percent of child-rearing expenses are made of transportation alone, while clothing composes 6 percent of this figure.
- Medical expenses are another big-ticket expense, making up another
 8 percent of this cost. Medical expenses include prenatal care, hospital fees, and medical care for your child after birth (annual check-ups, vaccinations, sick visits), etc.

As much as you love your child, try to be honest with yourself in evaluating your life now and in the future. One of the most common reasons a person places their child for adoption is a result of financial instability. They have considered the expenses that come with a baby and understand that perhaps they are not ready to raise a child at this moment. This does not mean they would not make great parents. It just means they understand their situation, and want what is best for the baby. By providing this child with a wonderful family that is ready to take on this responsibility, they are meeting the fundamental needs of the child, giving him or her countless opportunities, and ensuring a lifetime of stability and happiness.

If you decide that adoption is right for you and your baby, financial assistance through an agency is available. 
How to Make an Adoption Plan, con't

An open adoption plan gives you the freedom to get to know the adoptive family. Most significantly, it benefits your child, allowing him or her to achieve a stronger sense of self and identity, having answers from you and about you. Open adoption allows you to maintain contact with the adoptive family throughout the first 18+ years of your child's life, if you wish. You can feel comforted and at peace knowing how your child is developing through the years. Our adoptive parents are bounding with pride and love, and will be happy to update you regularly.

At **Adoptions With Love**, we maintain a letter and picture program between birth parents and adoptive families so you can receive updates on your child if you would like. Some prefer to remain anonymous while still receiving updates on their child, and a semi-open option gives them just that. Remember, though, that your plan will be distinctly your own. If an open plan seems overwhelming and you prefer to leave it all to adoption professionals, we completely understand. There is always the option of keeping your adoption closed. This enacts a more confidential plan, in which you as a birth parent remain anonymous. We will protect your identity. If you ever feel the urge to change this plan we can help you with that. If you decide you would like more information on your child's adoptive family, it will be available to you. At Adoptions With Love, we make a point to keep letter and picture updates on file in case you ever desire to see them in the future.
